

## Personal data processing consent

hereinafter referred as – Owner of personal data, am giving my consent to KIROV STATE MEDICAL UNIVERSITY, \_\_\_\_\_  
(name of the educational institution of higher education)

registered address: Kirov city, 112 K. Marx Street (hereinafter referred as the University), for processing of the Owner's personal data, stated in clause 3, under the following terms and conditions.

1. The Owner gives consent to the University for processing their personal data, that's is, performing the following actions: collection, systematization, accumulation, storage, rectification (updating, alteration), usage, distribution (including transmission), depersonalization, blocking, destruction of personal data (general description of the above methods of data processing is given in the Federal Law dated July 27, 2006, No. 152-ФЗ "On Personal Data"), as well as the right to transfer such information to third parties, if it is necessary to ensure and monitor the educational process, scientific, organizational, financial, and economic activities of the University, in cases established by the regulatory legal acts of the Russian Federation.

2. The University shall be obligated to use the personal data of the Owner to ensure and monitor the educational process, scientific, organizational, financial, and economic activities of the University in accordance with the current legislation of the Russian Federation. The University can disclose any information to law enforcement authorities upon an official request only in cases established by the legislation of the Russian Federation.

3. List of personal data given to the University for processing:

biographical information;  
information about previous education (city, name of educational institution, period of study);  
information about work (city, name of organization, job position, period of work);  
academic performance data;  
registration address;

video recording of the entrance examinations;  
information about parents;  
passport data (number, place and date of issue) and passport scan;  
SNILS number and scan (if available);  
information for financial organizations;  
information about payment (if applying on a fee paid basis).

4. The Owner agrees to include the following personal data in publicly available sources of personal data to ensure and monitor the educational process, scientific, organizational, financial, and economic activities of the University:  
name, surname, patronymic name;

gender;  
date and place of birth;  
citizenship;  
information about previous education (city, name of educational institution, period of study);  
academic performance data;  
electronic photo;  
contact information;  
information about parents;  
information about payment (if applying on a fee paid basis).

5. The Owner, upon written request, has the right to receive information regarding the processing of his personal data.

6. The processing of personal data not included in publicly available sources stops after six months from the date of completion of the admission campaign, and the data is deleted (destroyed) from the information systems of the University after the specified period (except for information, the storage is required by the legislation of the Russian Federation).

7. Upon receipt of the Owner's written application about termination of this Consent (in case of expulsion), personal data is depersonalized within 15 days (except for information, the storage of which is required by the legislation of the Russian Federation).

8. This consent is valid during the storage period of the Owner's personal file.
